



Inspiring Our Culture

Southern Indiana is a unique community with a rich heritage. The Ohio River shaped our borders, brought business and industry to our riverbanks and carved a culture steeped in tradition and pride.


Since 1991 the Community Foundation of Southern Indiana has made more than \$507,000 in grants to support the arts, our history and culture. Preserving our history – and who we are as a community – is an important part of inspiring future generations.

The Town Clock Church, located in downtown New Albany, is a treasure that stood as a beacon of hope for fugitive slaves escaping the auction blocks along the Louisville riverfront and the chains of slavery. It was common knowledge that if they could get to the church, whose steeple was visible as they were marched to the Portland wharf, there were people who would help them through the Underground Railroad. The late Dr. Blaine Hudson, a University of Louisville professor and author, called the crossing point between Portland and the church in New Albany "the most important crossing point in the greater Louisville area."

Over the years the church has faced a number of challenges in preserving its history, and our culture. Can you imagine losing such a wonderful structure and symbol that meant so much to so many? It's an important part of who we are and what we represent as a community.

To forever preserve the Town Clock Church for future generations, the Community Foundation of Southern Indiana joined together with others in our community to support the efforts to bring this building back to life.

Tomorrow's Education, Today

Writer G.K. Chesterton once said that education is "the soul of a society as it passes from one generation to another." Today, our community has the opportunity to shape the future of our region through education, and to imagine the soul of society we're shaping for future generations. Through the generosity of individual donors and the many funds that make up the Community Foundation of Southern Indiana, last year 98 scholarships were awarded to youth across our region to support their continued learning, dictionaries were distributed to every third grader in Clark and Floyd counties, and the Foundation continued to help guide the Youth Philanthropy Council and educate them on the importance of giving back to their community.

Think of our community years from now. How will education influence our children's children? What future do you imagine for our region?



Dr. Rita Hudson Shourds knew exactly the future her mother imagined when she established the Jean Sekora Hudson Educational Scholarship for Women. It is a permanent endowment fund that provides scholarship assistance for females graduating from Springs Valley High School in French Lick, Indiana. This year, and every year, through the fund established by Dr. Shourds, her mother will influence the lives of young women as they work to complete the next chapter of their education.

Last year, over \$375,000 in education support and scholarships from the Community Foundation of Southern Indiana was awarded in Southern Indiana. More than 2,500 dictionaries were distributed to third graders through the Dictionary Project. Can you imagine a community with nearly \$3 million more in education support for our youth? It's possible if we all make the choice to leave 5% to help shape our community through a bequest to the Community Foundation.

Dr. Shourds states, "It was so easy to partner with the Community Foundation of Southern Indiana to honor my mother and her values by setting up a scholarship fund that will last for generations and impact the lives of so many. My mother would have been so happy to know her legacy will live on through this fund and that she is helping shape the future of our region."

Education Matters Southern Indiana

Supporting education, providing scholarships, and creating opportunities for our youth is just a small part of how the Community Foundation of Southern Indiana supports education in our region and provides for our future. Increasing our educational attainment – the number of people with a completed form of post-secondary education – is another.

The Education Matters Southern Indiana ("EMSI") initiative was organized by the community foundations that serve Clark, Floyd, Harrison, Scott and Washington counties in Indiana to strengthen our workforce and improve the economic advantages of our region by increasing the educational attainment of those adults with some form of post-secondary education but no degree or certification.

Research shows that in this five county region, only 25% of the workforce has an associate's, bachelor's, or professional degree, compared to 38% nationally. Yet one in four – over 40,000 people – of the region's adult workers has earned some college credits. Those 40,000 people in our five counties represent an opportunity to increase the economic advantages of our communities, lure new businesses to our region, and enhance the quality of life for this and future generations.

Our goal is to increase our attainment numbers by 25% in the next 5 years (10,000 people). Providing For Our Most Vulnerable

In 2013 the Community Foundation of Southern Indiana granted over \$222,000 to area health and human service organizations. These organizations represent a broad range of services and help thousands of people each year here in our community and around the world.

Supplies Over Seas (SOS) is a nonprofit organization based in Louisville that meets the critical health care needs in medically impoverished communities around the world. SOS works with local hospitals and health care professionals to recover and redistribute surplus medical supplies and equipment that otherwise would end up in landfills.

Since 1993 SOS has distributed over 750 tons of supplies and equipment to 91 countries. With a focus on their future, SOS established an endowment fund at the Community Foundation of Southern Indiana that will forever support their mission.

Any individual or nonprofit organization can establish their own, unique endowment fund to support the causes they care most about. Whether you want to support your alma mater, church, environmental causes, the arts, or your favorite health and human services organization, it is possible through a fund at the Community Foundation of Southern Indiana.

Providing more, and better, care for the most vulnerable will always be a focus of the Community Foundation. Imagine the change we could make here at home and around the world if we each supported the causes we care most about through a fund at the Community Foundation. The Transfer of Wealth study estimates that with your help, we can contribute another \$1,750,000 per year to support our most vulnerable, and we could do it forever.

When Dr. Clifton's father passed away, he and his wife, Kim, wanted a way to honor his parents' belief that access to education was important for everyone. They called the Community Foundation of Southern Indiana to help them accomplish this goal.

The Youth Philanthropy Council (YPC) is designed to involve youth in meaningful ways, to encourage them to give and serve in their communities and to make philanthropy a habit for the future. Students from high schools across our region join the Council to learn about their community and the value of volunteerism.

In 2013, the YPC learned about the value of community service, philanthropy, and granted a total of \$5,000 to 10 not-for-profits that benefit youth in Clark and Floyd counties. Boys and Girls Clubs of Kentuckiana, Clark County Youth Shelter & Family Services, Hope Southern Indiana, Miles for Merry Miracles, New Albany-Floyd County Consolidated School Corporation, Open Door Youth Services, Rock Creek Community Academy, Voices 4 Youth, West Clark Community Schools, and Youth For Christ all received grants for involving youth in their organizational program planning or implementation.

The Mike and Tammie Ricke family knows a thing or two ... or five about the YPC and the impact it has on youth in Southern Indiana. Each of their five children have been four year members of the Council. Mike said, "YPC was a great program for our children. It gave them the opportunity to meet with peers and discuss regional issues while showing them how service and philanthropy can improve our community. The knowledge they gained from YPC will have a lasting positive impact."

Imagine what impact the Youth Philanthropy Council could have on our community if every Southern Indiana resident left a gift of just 5% of their estate to the Community Foundation of Southern Indiana. It could mean an additional \$700,000 in grants to youth-focused programs in Clark and Floyd counties, every single year, forever.

Inspiring our Community

For years, our community has enjoyed spending time at the soccer fields located off Charlestown Pike in Jeffersonville. Families have spent hours at the fields as children practice and compete in local and regional soccer tournaments.

More recently, the City of Jeffersonville and the Clark County Soccer Association (CCSA) have worked to rebuild the fields in an effort to provide more opportunities for our region's residents, our youth, and to lure visitors from across the country to play on new state-of-the-art fields. During the fall 2013 grant cycle, the Community Foundation of Southern Indiana made a grant to CCSA to help support their efforts as they worked to secure funding for the Woehrle Youth Athletic Complex. Paul Duckworth, President of the Clark County Soccer Association, said, "With the help of the Community Foundation, we were able to produce presentation materials that showed what was possible at our site which, at the time, was undeveloped and hidden under brush and trees. This was a prime factor in securing funding for the project. It's incredible to think what we've been able to accomplish and how much more we can do by working together to better our community."

Inspiring our community takes vision and dedication. With the efforts and leadership of our community we can accomplish incredible things. In the fall of 2014, the Woehrle Youth Athletic Complex will be complete with a number of new soccer fields, two football fields and a variety of new options for families to get out and be active. Imagine how much more we could do by working together and leaving just 5% to the Community Foundation of Southern Indiana so we can keep inspiring our community forever.

Ways to Give

Each citizen in our community has unique interests and ideas for how to give back. Whatever your goals, whatever your means, whatever your passions, the Community Foundation will help you create a customized charitable fund to realize your dreams. Do you want to help students attend college? Would you like your children and grandchildren to one day help determine the charitable organizations that benefit from your fund? Are there specific non-profits — perhaps your alma mater or church — that should always benefit from a fund you create? Is there a particular area of interest, such as children's health, the environment or education, that you would like your fund to always address? Or do you simply want to give back to your community and help address its greatest needs at any given time?

All of these goals are possible through a customized charitable fund created at the Community Foundation. If you can dream it, we can help you achieve it.

Permanent Endowment Funds

Donors who would like to create a permanent legacy for their charitable interests may establish an endowment fund. With endowment funds, principal is never spent. Instead, a portion of earnings becomes available each year, based on the Foundation's spending policy, for grants to the donor's specified charitable cause. Endowment funds are a wonderful way to support your favorite organizations or interests, in your name, forever.

Pass Through Funds

Donors who want to streamline their current giving often establish a pass through fund at the Foundation. With an initial minimum gift of \$1,000, your fund may make grants of all or any part of the fund balance, at any time, to your favorite charitable causes. Many donors make additional contributions to their fund over time to sustain current giving. You keep track of only one tax receipt, but may make as many charitable gifts as you like from your single contribution. Pass through funds are an excellent way to take advantage of a windfall or bonus, or the need for an income tax charitable deduction, and can help simplify your giving year—round.

We make your giving easy, flexible and meaningful. We take all of the administrative details, investment issues, reporting and regulatory requirements out of your hands. You simply decide the charitable purpose of your fund, and we do the rest. A single gift can create a fund that will further your personal giving goals in perpetuity.

In 2013 the Community Foundation granted more than \$117,125 to 58 organizations serving residents of Clark and Floyd counties from the Foundation's Community Endowment, our unrestricted permanent endowment fund. This discretionary fund is used each year by our board of directors, and our Community Grants Committee, to award grants that provide for the community's most pressing needs in Clark and Floyd counties.

If you want to give back to the community you call home, but don't have a specific cause in mind, you can contribute to the Foundation's Community Endowment, which benefits our entire service area. A minimum gift of \$1,000 creates a Community Endowment Fund named for you. This is the most flexible type of fund for anyone who wants to give back to the community. Each year the Community Foundation offers competitive grants through our Community Endowment Fund to local 501(c)3 non-profit organizations. These non-profits must serve residents of Clark or Floyd counties but need not be physically located here. We look for existing or innovative programs that serve broad sections of the population. We primarily fund needs in the areas of arts and culture, community development, education, health, human services, recreation, environment and youth development. Each fall, grants of up to \$5,000 are awarded to deserving organizations.

While we awarded more than \$100,800 in 2013, the need always exceeds available resources.

## Making Plans Now, For the Future

There are several ways to structure a legacy gift that allows you to create your future philanthropic plan now, while postponing the transfer of assets to the Community Foundation until after your lifetime.

Bequest or beneficiary designation. Under these popular options — naming the Community Foundation in your will or trust or as a beneficiary on a life insurance policy or retirement account — you retain the use of your assets or property now while creating perpetual support for your favorite causes after your lifetime. You can change these plans until your death.

Charitable lead trust. This option allows you to create a trust to make annual income payments to the Foundation for several years to build your legacy fund. The balance of the trust is then distributed to your selected beneficiaries.

## Give Now, Receive Income For Life

You can create your future legacy fund now by making a gift to the Foundation that provides income for you and/or others for life, then creates an endowment fund to fulfill your charitable objectives after your or their lifetime.

Charitable gift annuity. You receive a guaranteed, fixed annual payment for your lifetime in return for a present-day gift to the Foundation to create your future legacy fund. You may receive payments immediately or defer them into the future; for example, when you plan to retire.

Charitable remainder trust. You create a trust with your present-day or testamentary gift to the Foundation. The trust provides income to you and/or someone you name for life. Then, at the income beneficiary's death, the remainder of the trust creates your permanent legacy fund.
