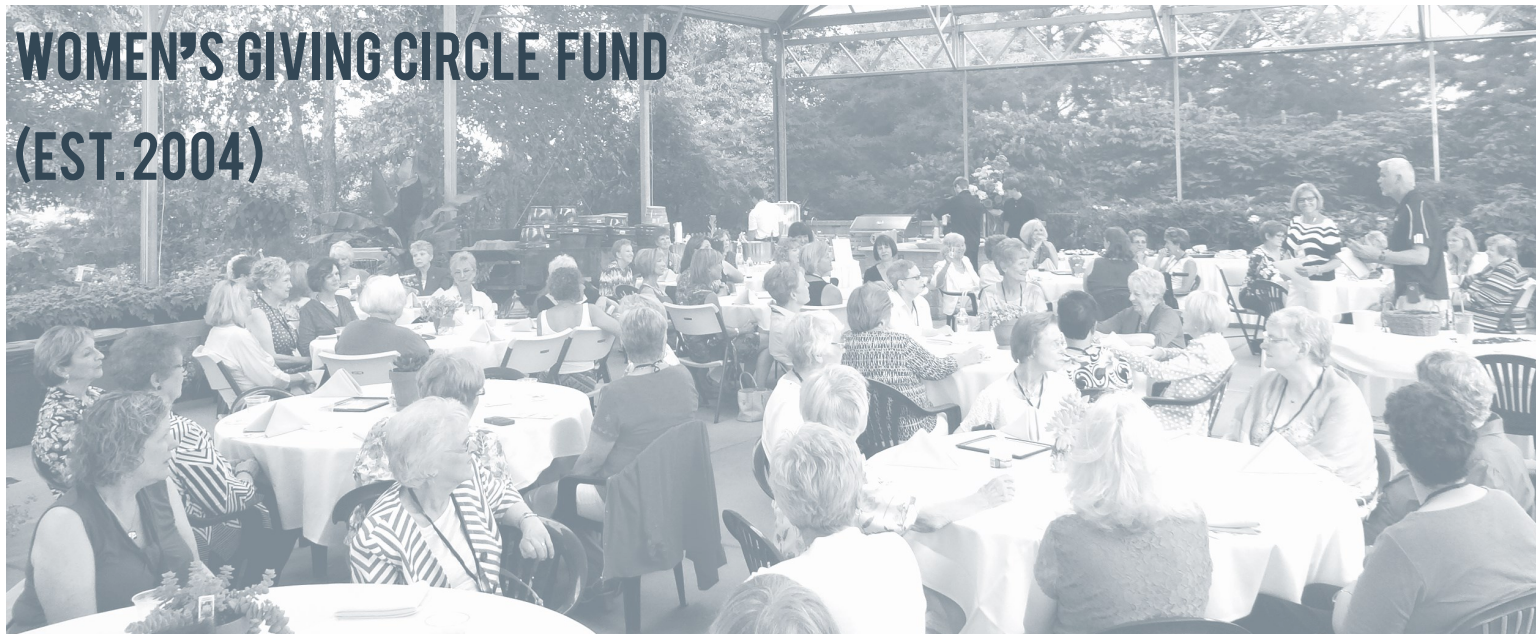

# SCHOLARSHIP FUNDS

Students pursuing degrees beyond high school were given some additional financial help this year from the CPCF. The Foundation awarded **more than \$250,000 in 2014**.
