We are proud to present this annual summary report of our activities in 2009. Throughout this document, you will see how the assets entrusted to us are being used to support the many causes important to us all.

During a time when our community and the entire world faced the uncertainty of the worst economic period in decades, the Harrison County Community Foundation remained committed to our goals. The Foundation awarded over \$1,800,000 in grants to our non-profit partners and provided over \$600,000 in scholarships to Harrison County residents.

We continued funding for our special programs in 2009. The Dictionary Project provided a new dictionary to over 500 third-graders throughout Harrison County this year. Dolly Parton's Imagination Library continues to provide books to over 1,700 registered pre-school children each month. Our 21st Century Scholars incentive project resulted in tripling the number of enrolled students.

There were 426 donors who contributed into endowments and nine new funds were created by friends who chose to give back to their community. We are always grateful for the opportunity to assist citizens who have created or support funds held by the community foundation. We hope you will be inspired as you read about these generous community benefactors.

National Standards establish legal, ethical, and effective practices that withstand the scrutiny of donors, government and media. Community Foundations use National Standards to promote self-regulation in a manner viewed positively by the Internal Revenue Service which has increased its scrutiny of charities. These Standards set consistent expectations among community foundation boards and provide a framework for documenting, communicating and providing training and technical assistance to advance best practices. It affirms our commitment to financial security, transparency and accountability.


21st Century Scholars Incentive Program

In 2009, seven Partners joined the Foundation to provide incentives to promote enrollment in the 21st Century Scholars program in Harrison County. 

Reaching for the Stars

HCCF continues to provide scholarships to Harrison County graduating high school seniors and some adults to help further their education. In 2009 over 200 various scholarships were awarded. HCCF Founders Scholarships are awarded at no less than \$1,000.00 and 10 percent of each school's total amount must be distributed to students entering a certified vocational training program. The Building Our Future Scholarships provide ten \$20,000 scholarships; \$5,000 renewable upon meeting criteria, for four years. Amounts awarded at each high school are based on reported number of seniors expected to graduate in May. Many scholarships are also awarded from the many restricted scholarship endowment funds created by members of the community. The Foundation now holds over 60 of these scholarship funds and more than 70 scholarships were awarded from these funds last year.

How to apply for a grant

All not-for-profit agencies providing services to residents of Harrison County, Indiana are eligible to apply. Applicants are required to submit the IRS Letter of Determination indicating their status as a 501(c)3 not-for-profit. Entities eligible to apply, but excluded from the IRS Letter of Determination requirement include schools, religious organizations, some civic organizations and local governmental units.

Spring and Fall Grant Cycles

HCCF typically awards grants twice a year. Applications for the Spring Grant Cycles are accepted after December 1 each year and must be submitted no later than January 15. Applications for the Fall Grant Cycles are accepted after June 1 and must be submitted no later than July 15. Application deadlines will be posted on the HCCF web site, listed in local newspapers and in HCCF monthly e-newsletters.





The Mail Pouch Barn on Highway 62 at the east end of Lanesville has long been associated with the Lanesville Heritage Weekend Festival and is a Harrison County Landmark. Community Foundation grantmaking assisted with renovation and preservation of the historical barn in 2009.

Signature Grant Requests

HCCF has no limit on the amount of funding requested. However, requests \$200,000.00 and over are considered Signature Grants. HCCF accepts Signature Grant applications November 1 - December 15 each year. These applications will be reviewed by all members of the Grants Committee. Applicant agencies must submit an original and eighteen copies of their application and all attachments. Decisions for Signature Grants may be announced anytime during the following year. After an initial review of a Signature Grant request, the Grants Committee may require additional information, presentations or site visits.

Special Grants

A vast majority of grant applications should be planned ahead and submitted during our Spring or Fall Grant Cycles, however, the HCCF is aware that some state or federal grants requiring local matching funds are announced on short notice. To support Harrison County serving not-for-profits with local matching funds, we will consider certain grant requests anytime. Request letters must arrive at the HCCF office prior to 4:00 pm on the Monday before the monthly Board of Directors meeting (typically, the first Monday of each month).

The following guidelines apply:

- 1. Special grants will only be considered if the funding desired is time-sensitive in nature.
- 2. Priority will be given to special grants that leverage external funding to support a project.
- 3. A one-page letter or a complete grant application may be required including a complete application to the external grant making entity. Contact the HCCF Executive Director as soon as possible to discuss the project and determine the documentation HCCF will need to make a decision.

Emergency Grants

Emergency grants are awarded to respond to true emergency needs of our community or those that prevent an agency or program from carrying out primary functions or services, such as essential equipment repairs or disaster response services. Emergency grant applicants should call the HCCF office to discuss your need and determine additional information the board may require. Emergency grants are submitted via one-page letter. Request letters must arrive at the HCCF office prior to 4:00 pm on the Monday before the monthly Board of Directors meeting (typically, the first Monday of each month).

The letter should describe:

- 1. The total amount requested
- 2. The project requiring this funding
- 3. Why the project is considered an emergency or cannot wait for the traditional grant cycle.

Grant Application Training and Workshops

HCCF staff will provide training to all eligible not-for-profits serving our community on the proper completion of our grant application. All applicants are strongly encouraged to attend formal training sessions as announced (typically in May and November). In some cases, the staff may be able to provide individualized training at our facility.

Grant Making Process

Properly completed grant applications are recorded, catalogued and separated by category. The Grants Committee Chairperson will assign sub-committees and sub-chairpersons. Each sub-committee will receive a similar number of applications for review and scoring. Individuals score the applications and the sub-committee convenes as a group to determine a final ranking of their group's applications.

Once the sub-committees have concluded their work, the Grants Committee meets as a whole to again review, score and/or rank all applications. The final assessment and evaluation of the Grants Committee is presented to the entire Board of Directors as a motion for approval.

The Board of Directors will make a final determination of the grant applications and formally approve the amount to be awarded to each successful applicant. The Board of Directors' decision is final and will be announced via formal letter to each applicant agency and publicly in local media.

Grant Writing Tips

If you haven't applied to HCCF before, we strongly advise that you attend one of our grant application workshops held approximately two months prior to each grant application deadline. These workshops are recommended for all applicants to ensure you have the latest changes or new tips for a successful application. Contact the HCCF staff for scheduled dates.

We suggest that you complete your application at least a week early to allow the HCCF staff to preview your application. Once the application is submitted, no additions or corrections can be made to the application.

Include ALL documentation. Follow the checklist and instructions explicitly. The cover page should be on the top of all copies submitted. All copies should be identical and in the order requested. Any time a document on the checklist is not submitted with the application provide a written explanation in its place.

Submit only standard size paper (8.5x11) and avoid binding other than binder clips. Keep a copy of your application for future reference. We will not return or copy any materials.

Statistics are helpful to justify your proposal, but statistics specific to Harrison County residents will provide a better argument for funding. How many Harrison County residents have been served in the past or are projected to be served by your proposal if funded? What is the source and relevance of these statistics?

Avoid jargon, abbreviations or acronyms. Ask someone who is not familiar with the project to read and critique your application. Will they be able to understand and clearly explain what your project is, the cost, and the results you hope to achieve?





HCCF Grants continue to assist Blue River Services by providing funding needed to leverage state and federal dollars for housing projects in Harrison County. In 2009, the new Wyandotte House Youth Shelter opened as well as the Country Trace Senior Apartments in Palmyra.

The Community Foundation realized a solid year in its investment returns for 2009. After a volatile year in the investment markets the previous year, we were able to rebound with earnings of over 23%. The Finance Committee is diligent in their efforts to maintain the foundation objective of meeting the long term goals of preserving the real



purchasing power of the principal while providing a growing stream of income used to sustain the operations and grant making capacity of the Foundation.





Lanesville FFA Chapter **Scholarship**

St. John's Lutheran Church **Projects Fund**



The Harrison County Community Foundation announces the establishment of the St. John's Lutheran Church Projects Fund. The purpose of this fund shall be to support projects of the St. John's Lutheran Church with priority given to maintenance, improvements, or repairs of the church property and facilities.

St. John's dates back to 1846 when a group of German Lutherans organized the German Lutheran Christian Church. Two years later they built a very simple, very plain log church and changed their name to St. John's Evangelical Lutheran Church. The congregation affiliated itself with Synod in 1862 and built

Scholarship Funds - Scholarship funds are dedicated to providing grants for educational assistance to individuals seeking post-secondary education. We have over 60 scholarship funds that assist our graduating seniors with their educational goals. Some funds honor family, memorialize loved ones, or celebrate life achievements. Each fund has different eligibility requirements. Some awards are restricted to students graduating from certain high schools, students attending a named college, or those pursuing a specific field of study.

Designated Funds (and Agency Endowments) -Designated funds are earmarked for one or more charitable organizations, and all grants made from such funds will be made to (or for the use of) the designated recipient 501(c)(3) organization to support their work. If the recipient organization ceases to exist or changes its status or mission as a charitable organization, the Foundation's Board of Directors may exercise its variance power, selecting an alternate use for the fund compatible with its original charitable purpose.






