A Message from the President and Executive Director



"How wonderful it is that nobody need wait a single moment before starting to improve the world." — Anne Frank

The words and wisdom of Anne Frank echo the philosophy at the heart of your Jennings County Community Foundation (JCCF) throughout its history and 2013 was no exception. The Foundation was very busy this year in large and small ways in improving our community and changing our world for the better. Some highlights of our work this year include three specific areas:

Youth Initiatives

3rd Annual Reach Conference- Led by the Women's Giving Circle and supported by the Foundation the Reach Conference brought together for a workshop day 102 high school young women who learned about secrets for creating successful and meaningful lives.

Education Summit- Focused on scholarships and the need for more graduates with higher skill levels, over 20 key education leaders met at the Foundation for a half-day "summit" to discuss the issues and opportunities surrounding our youth of today.

Youth Philanthropy (Giving) Group- Yet to be officially named, nine young people from Jennings County High School have begun a journey to create a permanent Youth Giving Group that will be out in our community "paying it forward" and seeking ways to improve the community in which they live. Sponsored and supported by the Foundation, watch for more from this group in 2014.

Fund Building and Grant Making

Classroom Grants- Again this year, classroom grants were available to teachers for classroom projects and more teachers than ever applied for grants.

Challenge Grants- 2013 was our sixth year for issuing to the community Challenge Grants, where interested donors could have their donation matched at \$1 for every \$4 placed in the Foundation.

Competitive Grants- Again in 2013, the opportunity to apply for competitive grants was offered to the community. A record number of applications were received and over \$10,000 was awarded.

Fundbuilding Support- JCCF partnered with groups who were attempting to raise funds for numerous projects. One particularly significant effort was a partnership with Hayden Museum to host a Salute our Veterans day which was filled with food, guest speakers and performers, and fun. Funds raised went to support the Hayden Building Fund for the soon to be expanded Hayden Museum site.

Reaching Out to the Community

Farmers Breakfast- For the third consecutive year JCCF has sponsored a Farmer's Breakfast, showing appreciation of our farm families who regularly put food on all our tables.

2013 Gala- The Foundation hosted its 11th GALA in the spring, helping raise operating money for the foundation, but more importantly raising awareness of the good work of the foundation.

Calli Nature Preserve's New Trail- Our nature preserve now has a new walking trail for the enjoyment of all in the community who like to "take a hike" or just a leisurely walk on the beautiful grounds of Calli.

Use of Foundation Building- 2013 saw a record number of community non-profits use our building free of charge. It is truly the community's space in the community's foundation.

Estate Planning Workshop- 27 people attended the WCCF sponsored dinner and workshop on the important topic of estate planning and creating a will.

Along with the efforts to improve the community noted above, the foundation found time to create a new and easier way to give electronically to JCCF (see our website and the "donate now" button), pay off what was owed on our building—**Hooray we own it!**, and accept \$140,000 in new donations. As Anne Frank so aptly stated, *it is wonderful* to improve the world...of our community. **Don't wait a single moment, join hands** with us in our efforts in 2014 as it is a special year—our 20th Anniversary...and the best is yet to come! Giving... Why should I give to the Community Foundation?

★ The Foundation provides *permanence* for your gifts.

★ The Foundation provides *flexibility*. Gifts can be cash, shares of stock, life insurance or real estate.

★ Gifts to the Foundation can *reduce your tax burden*.

★ The Foundation's Board, Finance Committee, professional staff and investment managers provide *prudent stewardship* of donor funds.



Ways You Can Give...

Cash – your donation can be directed toward a specific charity or used at the discretion of the Foundation.

Through a Bequest – the value of a bequest is not subject to estate taxes.

Life Insurance – your charitable tax deduction would be less the cost of the cash value of the policy. If you continue to pay annual premiums, these too are tax deductible. The future benefit to the Foundation would be equal to the face value of the policy.

Charitable Lead Trust – you give your assets to the Foundation for a designated period of time. Income from the assets is available for grants. After the designated period, the property and trust can be returned to you or your estate. You pay no income or capital gains tax during the period the Foundation manages the assets.

Stocks and Bonds – you receive a charitable tax deduction equal to the fair market value of any marketable securities that have appreciated in value since purchased. You pay no capital gains tax.

The funds from this designated fund will provide support for the upkeep and maintaining historically significant sites and bring out the beauty of the cemetery for posterity.



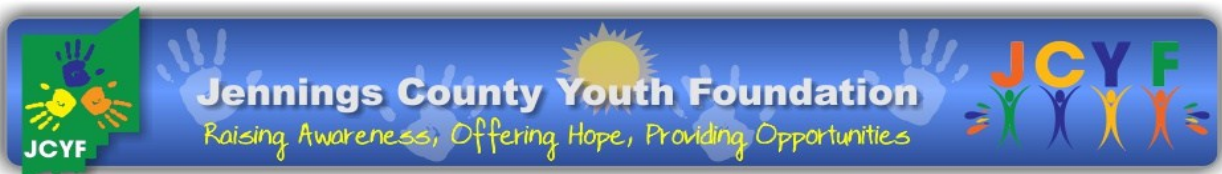
Jennings County Home Extension

2013 New Funds

Charley Dove Scholarship

The purpose of the Fund shall be to provide support for educational scholarships for students who are accepted into and attend accredited two- or four-year public or private institutions of higher learning. Student(s) who are graduates of Jennings County High School who will be continuing his/her education by attending a public or private institution of post-secondary learning in any field of study which deals with the autism spectrum.



The purpose of the Fund shall be to provide support to the **Jennings County Youth Foundation**. Initial use of the fund will be for the purpose of construction or possession of a building. Funds received over and above the cost of the building will be applied to the initial operation costs for the Agency.

2013 Classroom Grants

Every year the Foundation awards classroom grants to teachers so that they can launch special projects that would otherwise not be funded. The grants are made in order to broaden students learning by engaging them in creative initiatives. In 2013, the Foundation awarded in classroom grants.

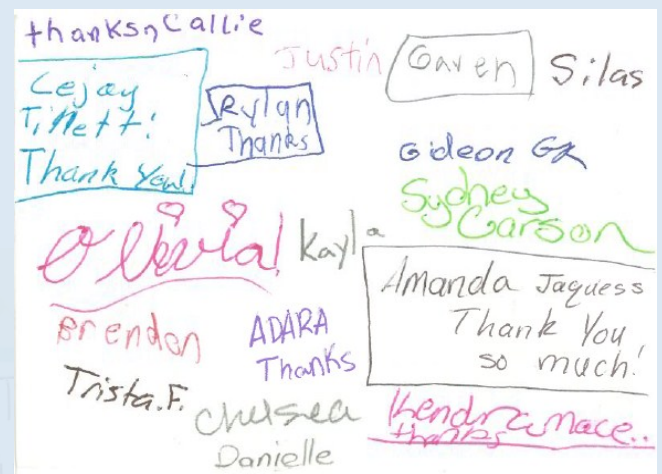

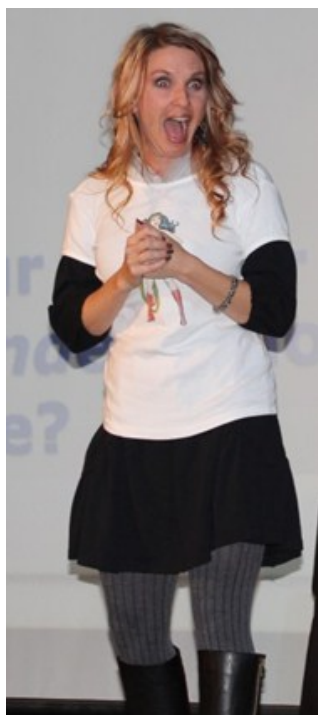

Morgan Wright Memorial Scholarship

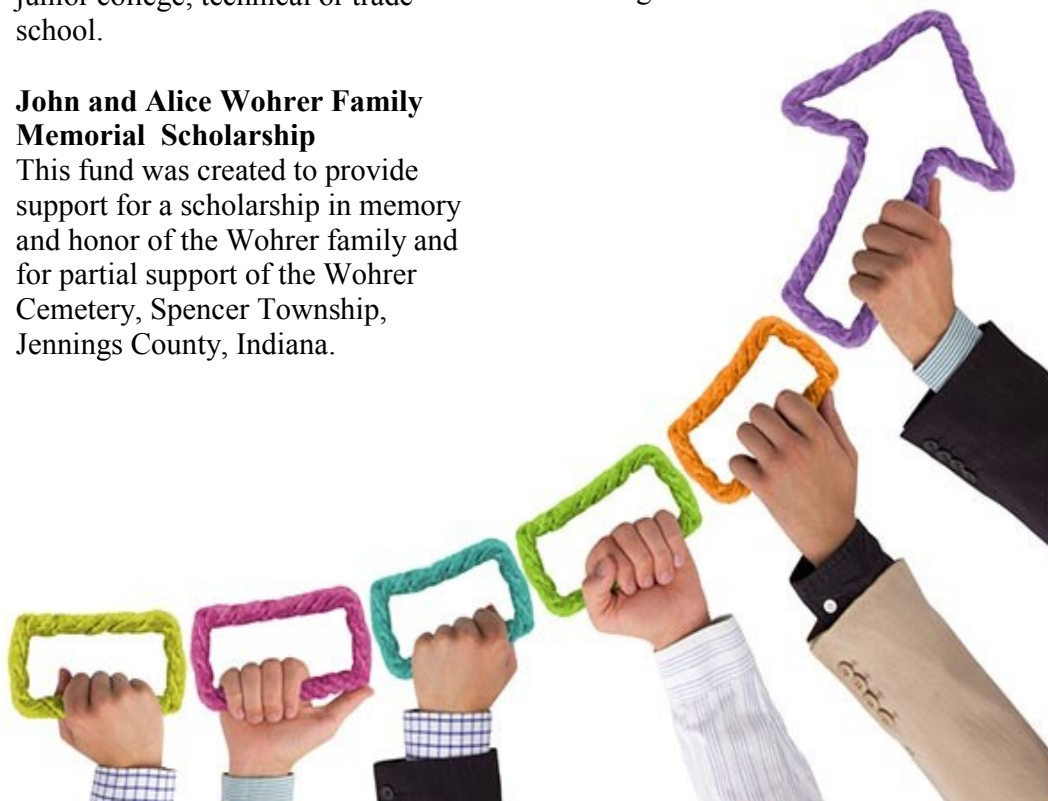

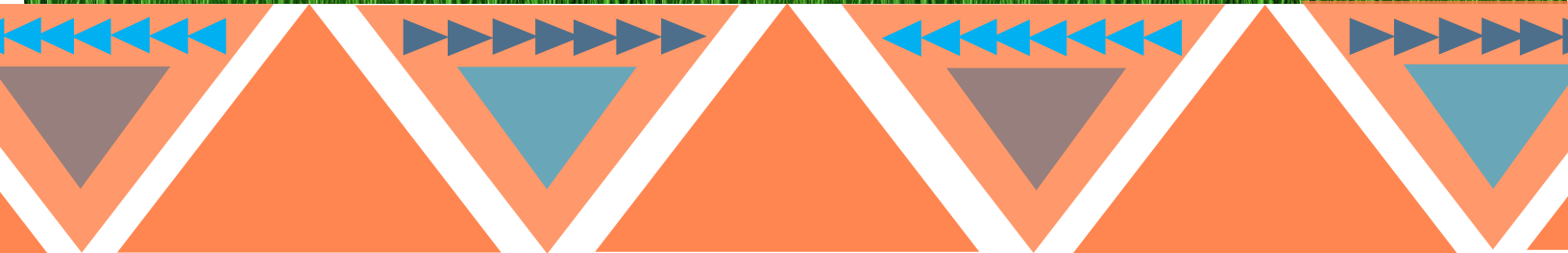
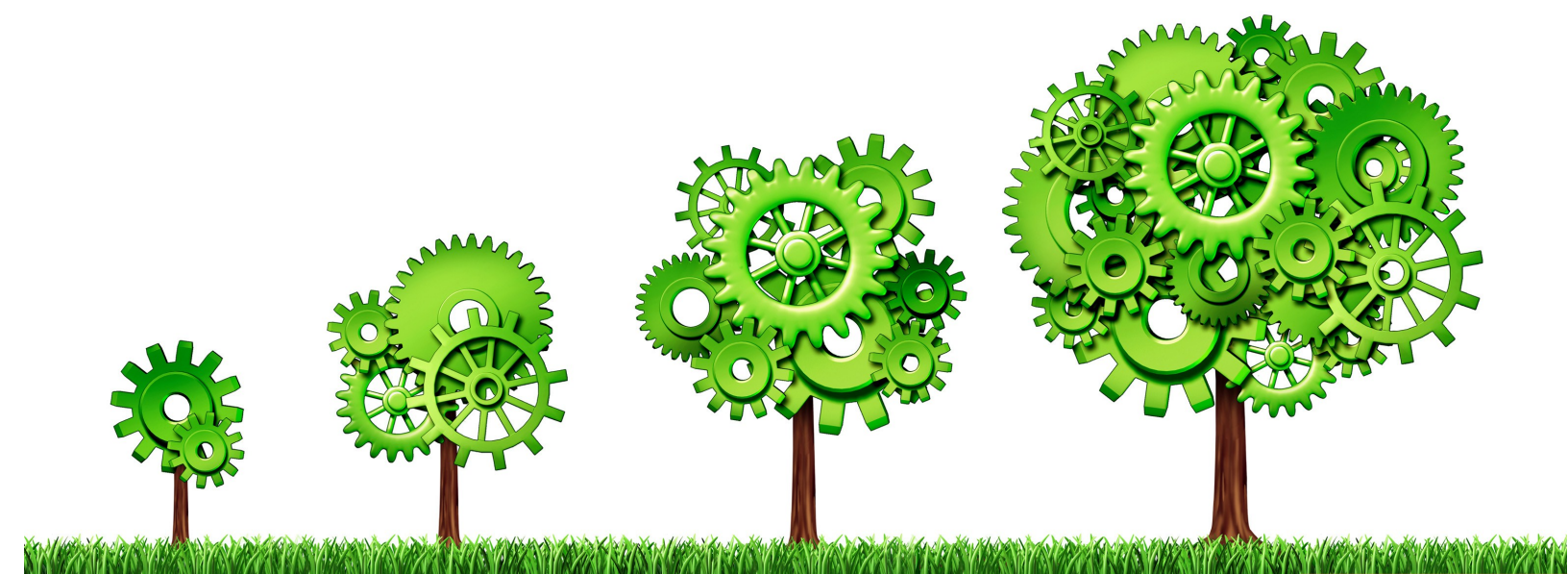
