Mission

The Hugh J. Andersen Foundation's mission is to give back to our community through focused efforts that foster inclusivity, promote equality, and lead to increased human independence, self-sufficiency and dignity. To fulfill this mission, the Foundation acts as a grantmaker, innovator, and convener.

History

The Hugh J. Andersen Foundation was incorporated on March 2, 1962. The original board members were Hugh J. and Jane K. Andersen, and Hugh's sister, Mary Andersen Hulings. They strongly embraced Andersen Family values learned from Fred, Molly, Isabel and Kitty Andersen: giving back to the community, being responsible citizens, and caring for their neighbors. The current board members continue to uphold this commitment, strive to build upon this spirit of philanthropy, and remain strongly supportive of the St. Croix Valley area.

The directors strive to instill in the next generation of Andersen family members the legacies passed on to them by the founders – the value of community and sharing. In 1994, the Next Generation Fund was created as a means for the next generation to learn the various aspects of philanthropy. The Next Generation Fund does not accept unsolicited requests as the members prefer to search out and fund organizations based upon their current geographic and program interest areas.

In 1994, Christine E. Andersen and Sarah J. Andersen each created their own fund within the Foundation to further promote their charitable interests in the community. Contributions from these funds are Foundation grants, not individual gifts. The Christine E. Andersen Fund will accept letters of inquiry if the Fund has provided past support. The Sarah J. Andersen Fund does not solicit nor accept requests.

Overview

The Foundation is particularly interested in asset-based programs created, initiated, supported or staffed by the constituency for whom benefits are sought. This type of effort builds upon and further develops individual and community capacities. These programs or projects are internally motivated and organized, rather than need-based, service-oriented systems brought in and directed by non-constituents.

• Geographic Focus

The Foundation's primary geographic focus area is the St. Croix Valley: Washington County in Minnesota and Pierce, Polk and St. Croix counties in Wisconsin. Programs in St. Paul, Minnesota unduplicated in the St. Croix Valley and utilized by St. Croix Valley residents may also be considered.

From time to time the Foundation may consider programs in other parts of the Twin Cities Metropolitan Area and Greater Minnesota. Please contact the Program Director prior to submitting a proposal to determine if the program might be of interest to the Foundation.

• Programmatic Focus

Within the primary geographic focus areas, the Foundation is particularly interested in direct service programs:

- Serving children and youth, especially those that provide personal development activities.
- Providing various social support services to the community at large.
- Providing access to health-related services and information.
- Providing educational opportunities and enrichment to the general community.

The Foundation will only consider the following types of programs and organizations if services are provided in the St. Croix Valley - Washington County in Minnesota and Pierce, Polk and St. Croix counties in Wisconsin:

- Special projects or programs in public schools.
- Programs for individuals with developmental or physical disabilities.
- Programs for seniors.
- Public/civic projects and activities.

2009-10 Highlights

In 2009-10, the Hugh J. Andersen Foundation paid 239 grants for a total of \$2,415,000. Highlights from the 2009-10 year include:

- \$20,000 for general operating support was granted to The Phipps Center for the Arts in Hudson, Wisconsin. The Foundation has been providing support to The Phipps since the organization was founded in 1984, awarding over \$165,000 in general operating, program and capital support.
- \$5,000 for Primary Medical Care for Individuals with HIV in Pierce, Polk, and St. Croix counties was granted to the AIDS Resource Center of Wisconsin. The Foundation has been providing support since 1995.
- \$6,000 was granted for the SafeZone Center for Homeless and Runaway Youth in St. Paul to Face to Face Health and Counseling Service.
- \$40,000 for general operating support was granted to Valley Outreach. Valley Outreach provides basic emergency assistance programs for low-income individuals and families living in the area served by the Stillwater Area Schools District. Programs include a food shelf, free clothing and household furnishings and an emergency fund.
- New capital grant awards were again severely reduced in 2009-10 due to the decline in the Foundation's assets. One exception was a \$15,000 grant to Northwoods Homeless Shelters to purchase a single family home in Amery, Wisconsin to create a new transitional housing facility.

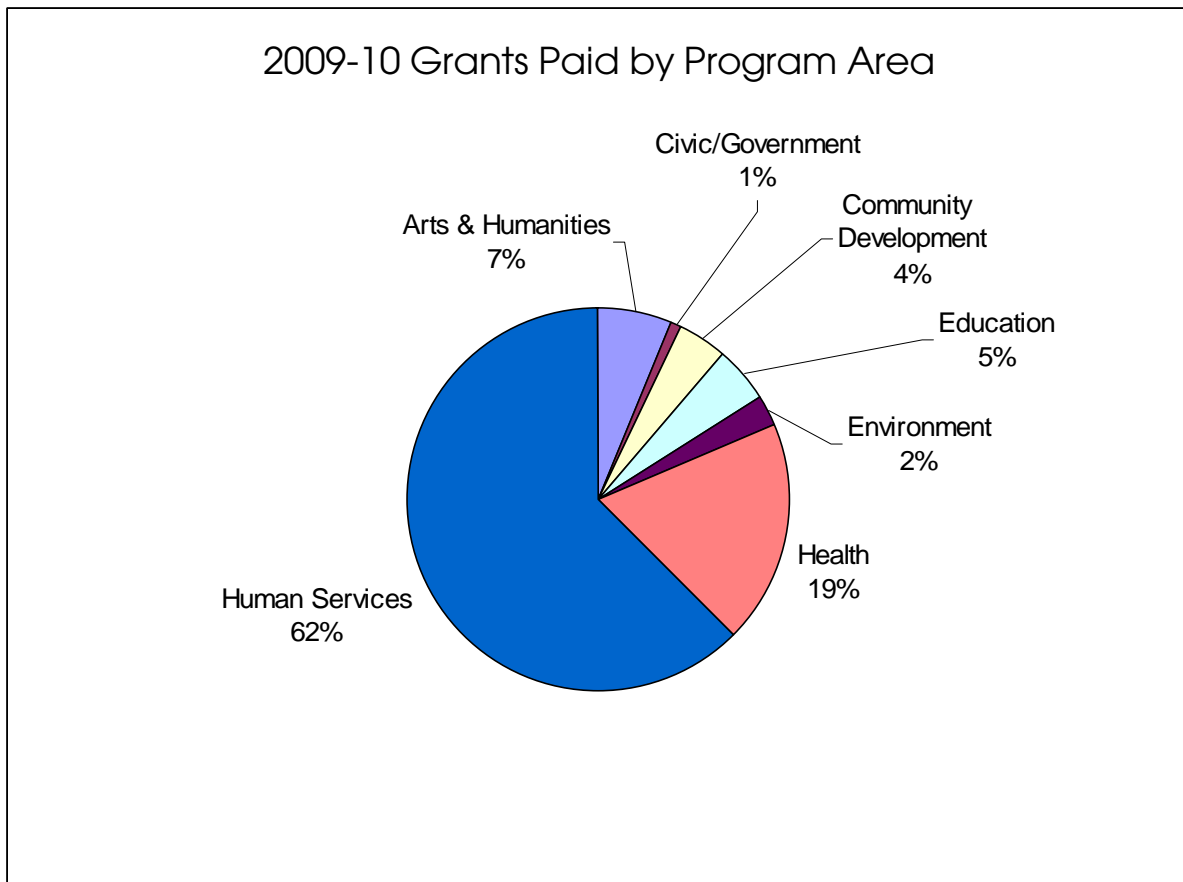
